

Addendum to the 2025 Community Infrastructure Fund Notice of Funding Availability: Supplemental Disaster Recovery Funding

Release Date: July 2, 2025

Closing Date: 30 days from the official opening of the addendum

Purpose

This addendum supplements the <u>2025 Community Infrastructure Fund (CIF) Notice of</u> <u>Funding Availability (NOFA)</u> to outline eligibility, priorities, and guidance for a new funding stream: the Supplemental Disaster Recovery Funding (SDRF) program. Funded through the <u>American Relief Act, 2025</u>, SDRF provides targeted infrastructure investment in communities affected by federally declared disasters between January 1, 2023, and December 31, 2024.

Program Overview

The SDRF program focuses on infrastructure recovery and resiliency within <u>Delta Regional</u> <u>Authority (DRA) counties and parishes</u> impacted by disasters declared under the <u>Robert T.</u> <u>Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. § 5121 et seq.)</u> during calendar years 2023 and 2024.

Eligible project types include:

- Basic public infrastructure (e.g., water, sewer, electricity)
- **Transportation infrastructure** (e.g., roads, bridges)
- Flood control projects (e.g., levees, stormwater systems)

Projects must support the agency's strategic goals: infrastructure improvement, economic development, and long-term community resilience. Projects must also align with current presidential administrative priorities as outlined in the "2025 Community Infrastructure Fund: REVISED Notice of Funding Availability Executive Summary."

Eligibility Requirements (Specific to SDRF)

To qualify under this addendum, applicants must:

- Meet the standard eligibility criteria of the CIF program (refer to Section C of the 2025 CIF NOFA)
- Be located in or serve communities receiving a federal disaster declaration between January 1, 2023, and December 31, 2024.

Availability of Funds

Total funds available: Approximately \$9.7 million

Cost-share requirement:

Projects serving <u>distressed or isolated areas of distress</u> are exempt from cost-sharing. Other projects are encouraged to offer non-federal matching funds. Projects that provide higher levels of non-federal cost-sharing may receive scoring preference.

Note on Funding Distribution:

Priority for funding will be given to counties and parishes within the DRA region that received a qualifying federal disaster declaration during the first quarter of 2023 (January 1 – March 31). However, all eligible counties and parishes within the DRA region that meet the federally legislated criteria—including receipt of a federal disaster declaration between January 1, 2023, and December 31, 2024—are eligible to apply and will receive full and fair consideration.

Application Process

Applications for SDRF must be submitted through the <u>CIF Application Portal</u> and clearly identified as submissions for **Supplemental Disaster Recovery Funding**.

- **Closing Date**: 30 calendar days from the official release date of this addendum
- Applications must follow all general instructions and submission requirements outlined in <u>Sections D and E and the 2025 CIF NOFA</u>.

Review and Award Administration

All SDRF-funded projects are subject to the award process and requirements outlined in <u>Section F, Section G, and the CIF 2025 NOFA Appendix.</u>

impact per dollar (e.g., leveraging in-kind contributions,	
economies of scale, or regional procurement).
